- A digital copy of the entry must be received by The Arc New York by **Friday, August 20, 2021.**
- Submissions should be emailed to Christina Canino at caninoc@thearcny.org
- Multiple photos of the artwork and the artist are requested
- Entrants must own all legal rights to submitted artwork

TO ENTER

Physical artwork, as well as the additional information necessary for the submission as named above, may be submitted to The Arc New York State Office, but is not required this year. Only a digital/emailed submission is required.

Winners of the Art Competition will be selected by a virtual judging committee and entrant submitters will be notified prior to the Art Competition Event Program. The Art Competition Awards will be presented during the virtual Annual Meeting on Wednesday, October 20, 2021 from 10:30-11:30 am.

Special guest Lauren Potter, from hit television shows like “Glee” and “American Horror Story” will be joining us this year for a special presentation after the Art Competition awards are presented.

This year, there are multiple categories for entry; painting, photograph, and sculpture. A first place of \$200, second place of \$100, and third place of \$50 will be awarded for each category.

Entrant retains ownership and all rights to submitted artwork; however, by entering the contest, entrants grant The Arc New York permission, royalty-free, to publish submitted artwork on the website, newsletter and to reproduce images for promotional purposes only. As conditions of this permission, The Arc New York will credit all artwork with the artist's name.
